Dear Magistrate Judge Parker:

Pursuant to the Court's Order of September 25, 2025 (Docket No. 36),¹ the parties provide the following status to the Court:

On October 2, 2025, the day after the Settlement Conference, Signify sent a draft Patent License Agreement to Nanoleaf in accord with the parties' executed Term Sheet.

Immediately upon completion of the October 1, 2025 mediation, counsel for Nanoleaf advised Signify's representative that counsel for Nanoleaf would be traveling over the next several weeks and that the earliest that Signify could expect to receive a response was about two weeks thereafter (about October 15, 2025).

On October 13, 2025, Signify sent an email to follow up to Nanoleaf. The same day, Nanoleaf's counsel responded "I have been traveling for other matters since our mediation on October 1. I will try to get you something later this week when I am back in the office." During that period, the CEO for Nanoleaf also was traveling overseas attending to other company business.

Counsel for Nanoleaf reviewed the draft provided by Signify and sent a draft to Nanoleaf for discussion and approval.

Unfortunately, counsel for Nanoleaf has not been able to finalize the Settlement and License Agreement last week because of a family emergency.

Accordingly, the parties respectfully request that this Court grant the parties until and including Friday, November 7, 2025 to finalize the Settlement and License Agreement between the parties.
